Tom Rushin made a motion for Board approval of the Rubber Flooring Projects Terms and Conditions as presented. Jeff Smith seconded. The motion Passed with a voice vote of 8-0.

Sean McCarthy made a motion for Board approval of Coolidge Unified's request to remove three schools from the District's

Sean McCarthy made a motion for Board approval of staff recommendation to deny conceptual approval for Casa Grande Elementary's request for a K-5 school for 750 students (007N). Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Sean McCarthy made a motion for Board approval of staff recommendation to deny conceptual approval for Florence Unified's request for a 9-12 school for 1,200 students (017N). Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Board approval of staff recommendation that Sahuarita Unified be conceptually approved for a 9-12 for 1,000 students to be approved in FY 20.Vern Crow seconded. The motion Passed with a voice vote of 8-0.

g. Santa Cruz Elementary

Sean McCarthy made a motion for Board approval of staff recommendation that Santa Cruz Elementary be conceptually approved for additional K-8 space for 50 students to be approved in FY 21.Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Kirkland Elementary ID2563 010BRG

Sean McCarthy made a motion for Board ratification that Kirkland Elementary be awarded \$4,126 in Building Renewal Grant funding to replace the kitchen sewer lines serving the multipurpose Building 1006 at Kirkland Elementary School. This includes \$500 in contingency that will only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Kirkland Elementary ID2586 011BRG

Sean McCarthy made a motion for Board ratification that Kirkland Elementary be awarded \$6,575 in Building Renewal Grant funding to replace approximately 40 feet of old clay pipe sewer line that serves the main Building 1001 at Kirkland Elementary School. This includes \$1,200 in contingency that will only be used with SFB staff approval. Vern Crow seconded.

The motion Passed with a voice vote of 8-0.

Pavson Unified ID2579 008BRG

Sean McCarthy made a motion for Board ratification that Payson Unified be awarded \$4,037 in Building Renewal Grant funding for the replacement of a 480 volt transformer on Building 1014 at Payson High School (project number 040210201-1014-008BRG). This includes \$400 in contingency that will only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

b. Consideration and possible vote to accept, reject or modify Building Renewal Grant Requests - Supplemental Award

The Board asked questions and discussed various aspects of the requests.

Canon Elementary 006BRG

Sean McCarthy made a motion for Board approval of the staff recommendation that Canon Elementary be awarded an additional \$5,000 in Building Renewal Grant funding for the structural engineering design, drawings and construction observations for the roof HVAC curb repairs at Canon Elementary School (project number 130350101-1002-006BRG). This brings the total project cost to \$60,710.Tom Rushin seconded. The motion Passed with a voice vote of 8-0.

Kirkland Elementary 009BRG

Sean McCarthy made a motion for Board approval of the staff recommendation that Kirkland Elementary be awarded an additional \$34,530 in Building Renewal Grant funding to restore the roof on classroom Building 1002 at Kirkland Elementary School (project number 130323001-1002-009BRG). This includes \$3,000 in contingency that may only be used with SFB staff approval and brings the total project cost to \$35,980.Tom Rushin seconded. The motion Passed with a voice vote of 8-0.

Mesa Unified 007BRG

Sean McCarthy made a motion for Board approval of the staff recommendation that Mesa Unified be awarded an additional \$6,626 in Building Renewal Grant funding to restore an existing foam-coated roof at Carson Junior High School (project

number 070204252-1016-007BRG). This brings the total project cost to \$28,126.Tom Rushin seconded. The motion Passed with a voice vote of 8-0.

Solomon Elementary 005BRG

Sean McCarthy made a motion for Board approval of the staff recommendation that Solomon Elementary be awarded an additional \$8,000 in Building Renewal Grant funding to replace the shingled roof serving Buildings 1002 and 1012 at Solomon Elementary School (project number 050305101-9999-005BRG). This brings the total project cost to \$32,500.Tom Rushin seconded. The motion Passed with a voice vote of 8-0.

c. Consideration and possible vote to accept, reject or modify Building Renewal Grant Requests - Construction Award

The Board asked questions and discussed various aspects of the requests.

Bullhead City Elementary ID2503

Sean McCarthy made a motion for Board approval of the staff recommendation that Bullhead City Elementary be awarded \$14,514 in Building Renewal Grant funding to replace carpets in classroom Building 1001 at Desert Valley Elementary School. This includes \$1,000 in contingency that may only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Camp Verde Unified ID2617

Sean McCarthy made a motion for Board approval of the staff recommendation that Camp Verde Unified be awarded \$54,360 in Building Renewal Grant funding for environmental remediation services and for additional classroom fungal investigation at Camp Verde Middle School. This includes \$5,000 in contingency that will only be used with SFB staff approval. Tom Rushin seconded. The motion Passed with a voice vote of 7-0.

Casa Grande Elementary ID2456

Sean McCarthy made a motion for Board approval of the staff recommendation that Casa Grande Elementary be awarded \$8,700 in Building Renewal Grant funding for the replacement

of a chiller pump that services the entire campus at Saguaro ElementarySchool. This includes \$791 in contingency that will only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Colorado River Union ID2589

Sean McCarthy made a motion for Board approval of the staff recommendation that Colorado River Union be awarded \$1,800 in Building Renewal Grant funding to replace the annunciator panel in the gymnasium Building 1009 at River Valley High School. This includes \$500 in contingency that may only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Colorado River Union ID2590

Sean McCarthy made a motion for Board approval of the staff recommendation that Colorado River Union be awarded \$8,000 in Building Renewal Grant funding to replace the fire door in the cafeteria Building 1002 at River Valley High School. This includes \$900 in contingency that may only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Colorado River Union ID2595

Sean McCarthy made a motion for Board approval of the staff recommendation that Colorado River Union be awarded \$3,950 in Building Renewal Grant funding to repair the walkway lights around Building 1001 at River Valley High School. This includes \$950 in contingency that may only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Joseph City Unified ID2610

Sean McCarthy made a motion for Board approval of the staff recommendation that Joseph City Unified be awarded \$40,000 in Building Renewal Grant funding to repair the ceiling on Gymnasium Building 1001 at Joseph City Elementary School.Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Kirkland Elementary ID2550

Sean McCarthy made a motion for Board approval of staff recommendation that Kirkland Elementary be awarded \$33,500

in Building Renewal Grant funding for the design, structural, administration and cost estimate to replace two 7.5-ton gas package units on the multipurpose Building 1006 at Kirkland Elementary School. This includes \$2,500 in contingency that will only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Palo Verde Elementary ID2588

Sean McCarthy made a motion for Board approval of the staff recommendation that Palo Verde Elementary be awarded \$7,040 in Building Renewal Grant funding to repair the piping connections and pipe from the septic lift station pump basin. This includes \$1,000 in contingency that will only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Safford Unified ID2587

Sean McCarthy made a motion for Board approval of the staff recommendation that Safford Unified be awarded \$5,674 in Building Renewal Grant funding to replace the refrigeration equipment on the walk-in freezer in the cafeteria Building 1002 at Safford Middle School. This includes \$1,000 in contingency that will only be used with SFB staff approval. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Cartwright Elementary ID2346

Sean McCarthy made a motion for Board approval of the staff recommendation that Cartwright Elementary be awarded \$17,588 in Building Renewal Grant funding for the design of the roof replacement on Building 1001 at Estrella Middle School.Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Prescott Unified ID2602

Sean McCarthy made a motion for Board approval of the staff recommendation that Prescott Unified be awarded \$25,400 in Building Renewal Grant funding for the roof investigation assessment, design, scope of work and bidding of the main

Building 1001 at Prescott High School.Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Scottsdale Unified ID2555

Sean McCarthy made a motion for Board approval of the staff recommendation that Scottsdale Unified be awarded \$4,800 in Building Renewal Grant funding for design services to replace a HVAC split system on Building 1006 Classroom D7 at Hopi Elementary School. Vern Crow seconded. The motion Passed with a voice vote of 8-0.

Yuma Union ID2510
