IV. Consent Agenda

The Board asked questions and discussed various aspects of the projects.

a. Agua Fria Union ID1029 Adjacent Ways

Vem Crow made a motion for Board validation of the Agua Fria Union request for Adjacent Ways expenditure for site improvements for safe ingress and egress for bus and fire lanes for the new high school that is being constructed, ID1029.Tom Rushin seconded. The motion Passed with a voice vote of 7-0.

Director Bakalis further stated these are estimates for remediation based on the Nogales experience and not quotes, that SFB will only spend what is necessary to do the testing, and that out of confirmation testing we hope to find simple protocol that costs less. Director Bakalis also stated SFB has made it clear to the joint legislative budget committee that this may have an impact on funding.
