III. Minutes

a. Minutes of 2016

Bob Rice made a motion for Board approval of the minutes of January 6, 2016; February 3, 2016; August 3, 2016; September 7, 2016; September 12, 2016; and December 8, 2016. Sandy Williams seconded. The motion Passed with a voice vote of 6-0. The other Minutes from 2016 (March through June, October and November) have already been approved by the Board. Mr. McCarthy also asked if Staff could organize the agenda by project category, stating it would be easier for the Board to digest, for the public to understand, and would hasten Board meetings.

In light of the limited amount of uncommitted funds remaining, with half of the fiscal year remaining, the Board approved a temporary policy relating to roofing and weatherization projects. The temporary policy will result in these projects being held at the construction phase until additional monies become available. The discussion also covered the need to preserve some BRG funding in anticipation of HVAC issues in the Spring.

Sean McCarthy made a motion for Board approval of a temporary policy relating to roofing and weatherization projects being held at the construction phase until additional monies become available. Bob Rice seconded. The motion Passed with a voice vote of 7-0.
