GRADING KEYNOTES

- 1 EXISTING PAVEMENT TO REMAIN.
- 2 EXISTING VERTICAL CURB TO REMAIN.
- 3 EXISTING CONCRETE SIDEWALK TO REMAIN.
- 4 SAWCUT EXISTING PAVEMENT 1' MINIMUM FROM EDGE, TACK AND JOIN NEW PAVEMENT TO EXISTING PAVEMENT, MATCH EXISTING PAVEMENT FINISH GRADE.
- 5 ASPHALT PAVEMENT TO BE 2.5"AC/4"ABC OR MATCH EXISTING PAVEMENT SECTION, WHICHEVER IS GREATER.
- 6 4" WHITE STRIPING.
- 7 CONCRETE VERTICAL CURB TYPE 2 (6" REVEAL) PER PAG SD 209.
- 8 CONCRETE CURB: NEW TO EXISTING CONNECTION PER PAG SD 211.
- 9 CONCRETE SIDEWALK PER PAG SD 200.
- 10 CONCRETE SIDEWALK: NEW TO EXISTING CONNECTION PER PAG SD 203.

- 11 GROUTED RIPRAP.
- 12 GRADING LIMITS.

13 4' X 1' CONCRETE CUT-OFF WALL BELOW GRADE. SEE STRUCTURAL PLANS FOR DETAILS OF WALL AND CUT OFF WALL.
