Thank you for the opportunity to submit a proposal for the above referenced project. We see our scope of services and related fees as follows:

A. TOPOGRAPHIC SURVEY

Perform topographic survey in the area of the proposed sidewalk ramps. The fee includes obtaining locations of existing street monuments so we can tie the new ramps to the street center line stationing per the City of Tempe requirements. The survey will be on the City of Tempe datum. Field acquire locations and elevations of existing improvements within the survey area. Finish grades will be obtained at 20-foot intervals and grade breaks. Above ground utility locations and underground utility locations shown on as-builts provided by the Owner or utility companies will be shown on the drawings.

FEE: \$ 2,220.00

B. GRADING AND DRAINAGE

Provide a grading and drainage plan as required by the City of Tempe for the installation of new ADA sidewalks ramps or a speed table/traffic calming ramp in front of Connolly Middle School. We will provide stationing and details as required by the City of Tempe. The fee includes submittal of plans to the City of Tempe.
