Requirements & Exclusions:

- All projects must abide to BWCDD Requirements and General Provisions.
- Liberty Elementary School District shall provide all executed easement/ROW agreements (in the format provided by BWCDD) to BWCDD prior to issuance of a Notice to Construct. Including, but not limited to, any easement/ROW agreements BWCDD requires from Liberty Elementary School District, the City of Buckeye, and MCDOT to complete the relocation of BWCDD facilities.
- Prior to Issuance of Notice to Construct, Liberty Elementary School District shall have all the construction area free and clear of incumbrances within the construction zone and BWCDD easement.
- All construction must match approved BWCDD project plan drawings.
- Pipe crossing transverse to the roadway will be slurry backfilled.
- Asphalt thickness is assumed to be a minimum of 4" and will be MAG ¾".
- All existing utilities within BWCDD must be lowered or relocated prior to construction, and properly licensed with BWCDD.
