- 16. No asphalt patching for all utilities performed by others.
- 17. One mobilization for Earthwork and ABC, and Asphalt, any additional mobilizations will be \$5,000.00.
- 18. ABC for concrete is excluded.
- 19. All permits: including building, right of way or any other.
- 20. Water and meter to be supplied by general contractor.
- 21. Payment to be as follow: 100% upon completion of work or a percentage of work completed as a progress billing.
- 22. Late Payment: When a payment is not made within one full billing period (30 days) from the thru date of the bill, the account will be classified as past due. A late payment charge of 2% per month, translating to 24% a year, will be added to all amounts billed excluding local taxes. Each customer's statement shows the through date and the date by which payment must be made to avoid the late payment charge. If this account is referred to an attorney or collection agency the buyer or 3rd parties his/her agent agrees to pay all attorney fees, lien fees, court and any other cost or fees necessary for collection.
- 23. Schedule to be agreed to by both parties.

Note: Due to the increasing price of material, the material price is good for 90 days. After 3/31/2025, the market price will need to be added. If Magnum Paving is granted job, bid proposal becomes part of contract.
