Description of work

This proposal includes labor, material and tax for the following:

Calling 811 to locate public utilities.

Placing barricades around area to be excavated.

Pulling back gravel away from the septic tank to provide access for excavating.

Excavating to expose entire septic tank lid on existing septic tank located in the southwest corner of the school, south of the modular buildings.

Removing plastic access covers and risers.

Cleaning off septic tank lid and inspecting lid for any signs of cracking.

Supplying and installing new concrete risers.

Supplying two cast iron manhole frames and covers stamped with "interceptor".

Processing spoils removed from excavation.

Backfilling and compacting.

Forming a 4' x 4' concrete pad around each manhole.

Placing two pieces of #4 rebar around manhole.

Mixing, placing and finishing concrete pad to finished grade.

Returning to remove forms, clean area and pulling gravel back over area where removed.

Picking up barricades and hauling away debris.

This proposal excludes but is not limited to the following:

Locating private utilities.

Pumping tank.

Removing or resetting lid for internal inspection.

Providing internal inspection.
