Allan, can you ask your people to break out the demo cost for just the main building portion? For whatever reason, they need the budget number to reflect just that space.

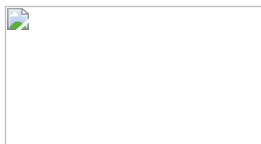

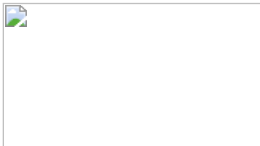
